


Specific OPIOID RELATED BEST PRACTICES TOPICS I would like to be FURTHER covered include:

- 51% of prescribed opioids in this country are consumed by individuals who have a
 diagnosed mental illness, regardless that only 16% of our population are those who
 have a mental illness. I've not seen anything that addresses this issue in the midst of
 the opioid craze.
- How should prescribers for chronic opioid therapy in personal patients document in his EHR?
- · How to manage controlling patients pain inpatient while not adding to risk of addiction
- Guidelines for ER clinicians as well as family practice providers. Best practices for communities including schools, law enforcement, parents, etc. Education on recognizing signs of opioid use. Options for referring patients for treatment.
